Pool Tag Distribution – 2026 Season

The Villages of Bear Creek HOA, Inc. will be issuing pool tags for the **2026 pool season**. Please review the updated process and requirements below.

Distribution Process

There will be **no in-person registration dates or walk-in availability**. All pool tags will be issued by **mail only**.

How to Request Pool Tags

- Complete the attached Pool ID Registration Form
- Submit the form through the resident portal **or** email it to: access@inframark.com

Processing & Delivery

- Requests will be processed within approximately **72 hours**
- Pool tags will be mailed to the property address on file (unless otherwise specified)

Important No in-office pickup is available

Fees Payable to Villages of Bear Creek HOA

- **Replacement Pool ID Card:** \$20.00 each (only if lost or new cards are needed)
- **Annual Sticker:** \$5.00 each (required each year for active use)

*Example: If you need three (3) replacement Pool ID cards, the total cost would be **\$60.00** (\$20 each).*

*If you already have your Pool ID cards and only need three (3) updated annual stickers, the total cost would be **\$15.00** (\$5 each).*
